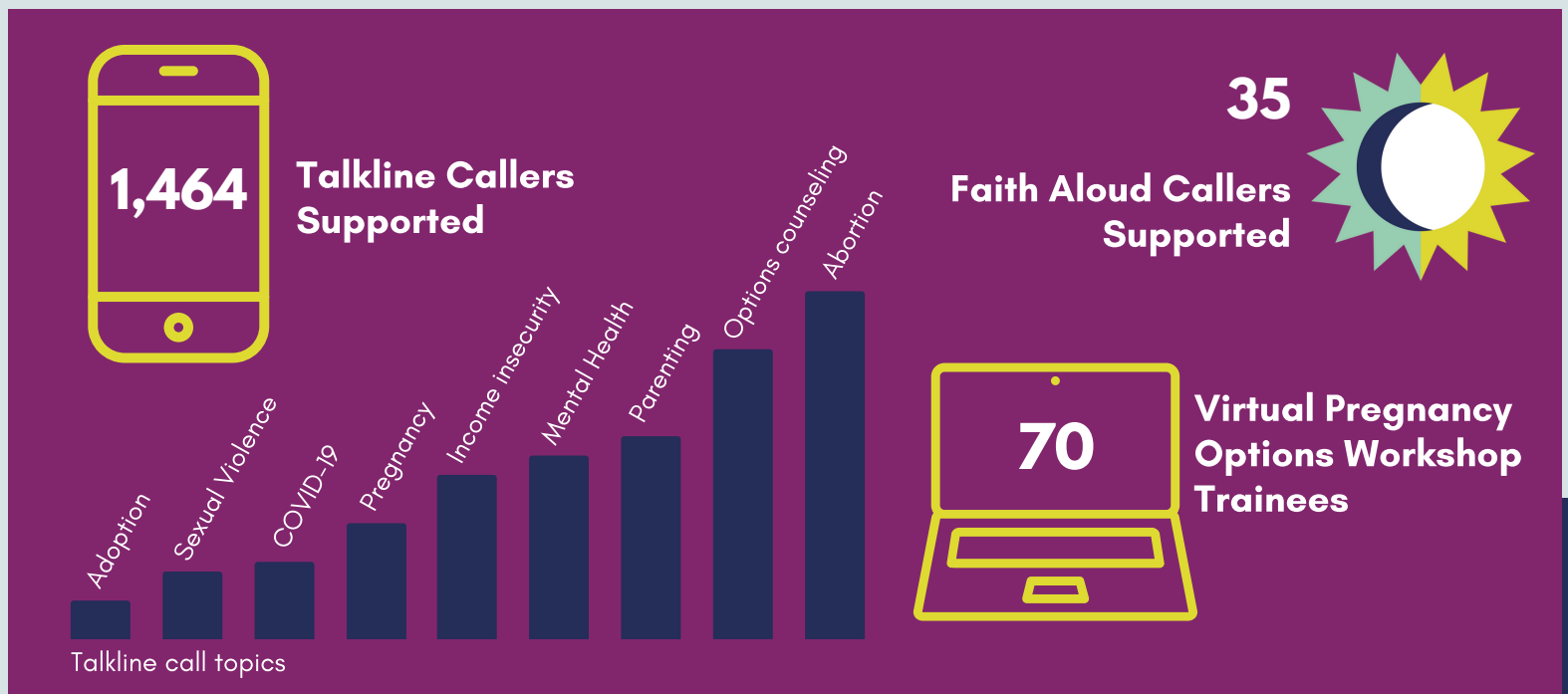

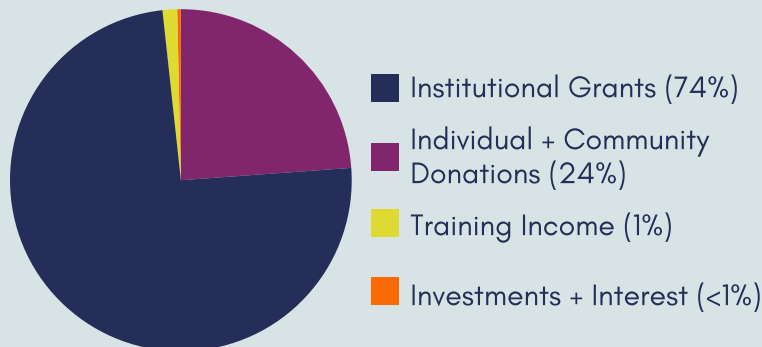

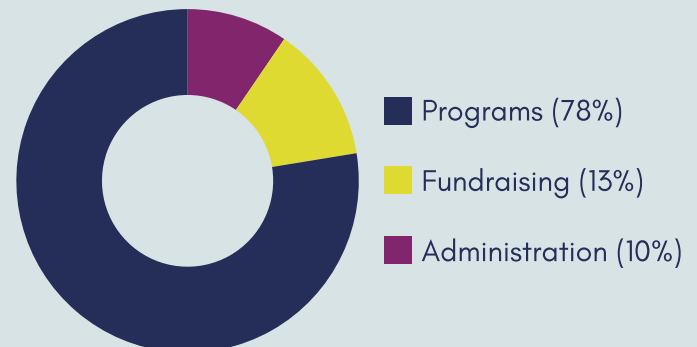

The generosity of our community kept All-Options in a healthy financial position throughout our 2020-2021 fiscal year. We ended the year with \$978,935 in assets and just \$115,625 in liabilities, the majority of which was a PPP loan that has since been forgiven.
