## A message from Executive Director J. Parker Dockray, MSW:

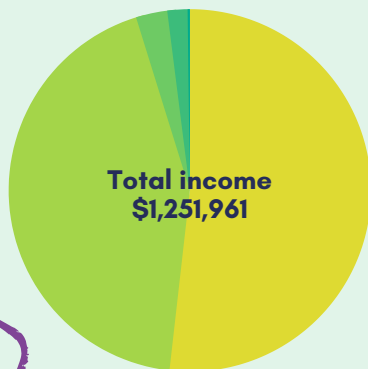

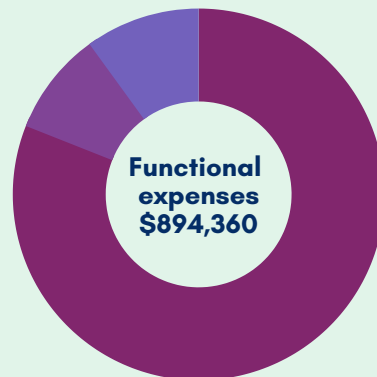


## FINANCIAL HIGHLIGHTS

Fiscal year 2021-2022 ended just after the SCOTUS ruling in *Dobbs v. Jackson*, which inspired the largest outpouring of donations All-Options has ever seen. 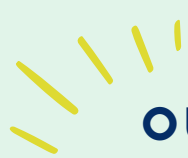


- Individual Donors (52%)
